Course Title: Painting I

Credit Hours: 3

I. Course Description: This course introduces the methods, techniques, and process of painting through a variety of media, but primarily acrylic painting. The elements and principles of art, color theory, form, light, and composition are explored. Executing conceptual and aesthetic solutions through the creative process, ideation, and experimentation is emphasized. Students are introduced to various styles, techniques, and artists through examples of professional work, demonstrations, and class activities. Students learn the process of developing a painting from sketches and studies to building compositions for final rendering. ART 115 fulfills The Arts SUNY General Education Knowledge and Skills Area. Prerequisites: None. 3 Cr. (2 Lec., 2 Lab.) Spring semester.

II. Additional Course Information:

1.	This course is an art elective and may transfer to four-year colleges. It is recommended as part of an art foundations study.
2.	Students are required to work on assignments outside of class.
3.	This course consists of at least 100 minutes of lecture and 100 minutes of lab work each week for the fifteen- week semester.
4.	The course is taught through lectures and demonstrations, critique, and guided coursework. Students are required to be actively engaged in course activities and group critique.
5.	The course has a fee of approximately \$100 to cover course materials. This fee does not cover any assigned course textbook.
