Course Title: Painting II Credit Hours: 3

I. Course Description: This course is a continuation of *Painting I* and focuses on the creative use of both acrylics and oils with an emphasis on oil painting. Developing expressive, conceptual, and aesthetic solutions through the creative process, ideation, and experimentation are emphasized. Students will examine various styles, techniques, and artists and improve their use of the elements and principles of art, color theory, form, light, and composition in their work. Mixed media techniques are also explored. ART 116 fulfills The Arts SUNY General Education Knowledge and Skills Area. Prerequisite: ART 115. 3 Cr. (2 Lec., 2 Lab.) Spring semester.

II. Additional Course Information:

- 1. This course is an art elective and may transfer to four-year colleges. It is recommended as part of an art foundations study.
- 2. Students are required to work on assignments outside of class.
- 3. This course consists of at least 100 minutes of lecture and 100 minutes of lab work each week for the fifteenweek semester.
- 4. The course is taught through lectures and demonstrations, critique, and guided coursework. Students are required to be actively engaged in course activities and group critique.
- 5. The course has a fee of approximately \$100 to cover course materials. This fee does not cover any assigned course textbook.
