Course Title: Hardware Repair and Maintenance Credit Hours: 3

**I. Course Description:** This course prepares students to design, build, upgrade, maintain, and repair computer information system devices. Students will develop skills which prepare them to pursue an A+ certification in hardware. Students develop these skills through hands-on and virtual lab experiences. Prerequisites: Prior completion of, or concurrent enrollment in, ENGL 100 or ESL 120, 121, and 122 if required by placement. 3 Cr. (2 Lec., 2 Lab.) Fall semester.
