Course Title: Short Narrative Film Writing

Credit Hours: 1

I. Course Description: Creative Writing course: This course explores creative techniques used to write screenplays for short films. Topics include story concept, structure, theme, setting, characters and dialogue, visual images, and sound. Students complete an original screenplay for a short film (under 30 minutes). Prerequisites: Prior completion of, or concurrent enrollment in, ENGL 100 and RDNG 116 if required by placement. 1 Cr. (1 Lec.) Fall semester (five weeks).

II. Additional Course Information:

1. This course is required for the Creative Writing – Screenwriting A.A. and the Creative Writing – Screenwriting Certificate. It can be used to fulfill a Liberal Arts or Unrestricted Elective credit in the Creative Writing – Prose, Poetry and Drama A. A. and an Unrestricted Elective credit in the Creative Writing – Poetry and Prose Certificate.
2. The course serves as a writing-intensive English elective, a humanities elective, a liberal arts elective, and an unrestricted elective.
3. Students with an interest in cinema, creative writing, screenwriting, video/film production, new media, or the creative process will benefit from taking this course.
4. This course requires class participation and group work as we read, critique, and workshop scripts.
5. Online homework is required.
6. This course uses specialized software as prescribed by the instructor, available at little or no cost to the student.
