Course Title: Writing and Grammar I

Year: 2023-2024 Credit Hours: 4

I. Course Description: This is a high-level beginning writing and grammar course intended for non-native speakers of English who need additional support to move from general to academic English. Students will develop basic writing skills including, but not limited to, the composing process, development of ideas, and sentence structure. Grammar work will emphasize simple verb tenses, uses of nouns, pronouns, and adjectives. Prerequisites: Appropriate assessment test score. 4 Equivalent credits. (4 Lec.)

2.	This course is a prerequisite for ESL 110 when required by initial assessment and advising.

1. Produce narratives with some control of basic grammar and sentence structure.	
2. Produce an organized, focused, and detailed paragraph.	
3. Use the principles of grammar to write sentences with correct word order.	
4. Understand the steps in the writing process, including planning, drafting, editing, and revising.
